CPH-45 HEALTH MANAGEMENT GUIDELINES

- Owned by seller at least 60 days
- Weaned a minimum of 45 days
- Eating from a bunk
- Drinking from a trough
- Dehorned and healed
- Castrated and healed (knife castration strongly recommended)
- Treated for grubs and lice (according to seasonal recommendations)
- Dewormed with endectocide a maximum of 60 days prior to the sale or 100 days, if using LongRange.
- Vaccinated for Clostridia (7-way or 8-way) according to manufacturers label instructions
- Vaccinated and boosted for IBR, BVD, PI3 and BRSV. Booster injection must be modified live
- Vaccinated for Mannheimia haemolytica toxoid ("Pasteurella")
- Calves must have access to a free choice mineral supplement containing a minimum 1,400 ppm copper (no copper oxide), 26 ppm selenium, 3,000 ppm zinc, 3,000 ppm manganese & 18-25% salt based on a 4oz. daily intake. No other salt available.
- BQA or BQCA Certified

*** All vaccines must be given no more than 90 days and at least 14 days before the sale.*

ADDITIONAL HEALTH GUIDELINES

- Check with your sale location for specific rules and requirements; sales may have guidelines and vaccination requirements beyond the state guidelines.
- Calves must be identified with official Kentucky CPH-45 tag. Tag should be placed in calves left ear

SORTING RESTRICTIONS

- NO VISIBLE horns or scurs
- No rat tails
- No Dairy cattle
- No shorts
- No pinkeye or severe scars
- No severe structural defects
- No defects or conditions that detract from appearance of cattle
